Motion:

Corrections Committee:

That the following paragraphs be added to page 16 of the AIP:

1.6.f.viii "The Pink Can" is a way for A.A. members and AA groups to contribute to the purchase of AA Conference approved Literature and Grapevines/La Viña for those who are confined in correctional institutions, Pink Can funds are exclusively to be used for this stated purpose and are to adhere to the same guidelines as set forth in paragraph vii as above." 1.6.f.ix - There is no difference between "Correction donations" and "Pink Can" donations. All donations to the Corrections Committee ARE Pink Can Donations." No funding is required. Motion by Stephanie M., District 12, second by Christine, District 5. FAILED.

Accessibilities & Remote Communities

Happy Winter Area 46!

Thank you District 17 for hosting such a wonderful assembly. The Accessibilities committee had 12 in attendance. We opened with the serenity prayer and introductions.

We discussed making a motion to include remote communities responsibilities under the Accessibilities committee responsibilities and how adding that will broaden the scope of what Accessibilities is already doing by including concerns that may be location, language and/or culture. A potential informational flyer or pamphlet with information on alternatives to face-to-face meetings such as email, Skype, phone, and snail mail was talked about to help provide information to remote communities.

The motion to make a motion to the assembly passed by the committee by majority, with one member against. This motion passed with the amendment to change the name of the committee to "Accessibilities and Remote Communities Committee" (ARC).

A member discussed a growing need for alcoholics who are becoming blind due to the illness of alcoholism and who do not read braille, to be able to participate more fully in service work, such as chairing a meeting. The committee discussed several clever ways to assist the blind alcoholic such as a person next to them to call on people in a meeting, recording the preamble to be played at the beginning of the meeting, and community resources for teaching braille to blind members that wish to learn. There has been a concern that helping members learn braille through an outside entity would break traditions, but the committee completely disagreed with this and explained why it does not. However, that member felt like GSO would not be supportive of their needs because they do not understand the issues that Native Americans face due to being in very

remote communities, who speak and read in their native languages, and have cultural differences. This issue is the exact reason for existence of a RemoteCommunitiescommittee:location, language, and culture.

Another issue discussed was lack of physical ability to go to a meeting because of stairs or poor access. Again some creative ideas were shared by committee members for current situations as well as how to approach a group conscience about moving locations.

Another was about how to reach out to DCM and GSRs to show them the support that can be accessed since there are groups that are becoming inactive due to people moving away, death, illness, etc. and they were the only members that knew how to keep meetings alive.

The final issue discussed was about childcare and there are groups that have come up with some great ways after a lot of struggles with this particular issue.

I would like to thank this amazing committee for all their participation within the assembly but mostly for all the hard work they do within their groups and districts. Some very smart and ingenious ideas have come from these awesome members. I was so impressed by how this committee jumps in to help members that have brought concerns to the committee. They are dedicated and passionate about helping to find solutions. I know they will continue to bring awareness and solutions of obstacles we place in front of recovering alcoholics and offering ways to try to allow the message of AA to be available to everyone who seeks it.

Again thank you to the committee and the area for allowing me to serve as Accessibilities chair. It has been an honor and a privilege to be allowed this opportunity.

Hello everyone!

Welcome to 2020 and the beginning of a new rotation at Area 46! I hope all of you had a Merry Christmas and are off to a good start for the New Year. I was sorry to miss the final assembly of my rotation as Archives Chair, but due to an unavoidable scheduling conflict I was unable to attend. Thank you to Debra K., Archivist, for chairing our committee meeting and to Patience B., incoming Archives Chair, for handling the archives display, for presenting the committee report to the assembly, and for providing me the information for this final report.

There were 10 people in attendance at the committee meeting. It began with the Serenity Prayer. Deb-

ra K. announced her resignation as Area 46 Archivist. She recapped the September meeting including the motion made and passed for her to research the availability and cost for Area 46 to rent space next to the Albuquerque Central Office to safely house and display the Area 46 archives.

Debra reported that there is space available that is large enough to fulfill the mission and scope adopted in September by the committee. The cost to rent the space would be \$3,000/year, including utilities, internet, cleaning, monitored security, and access to a conference room. Currently, the Area is paying \$900 per year to store the materials at the Central Office. Discussions included ideas for responsibility and pro-

cedures to manage the project and to subsidize the cost to Area 46. Patience B. agreed to research the idea of opening a bank account for monies collected. Patience also read the Mission Statement, as presented by Jennifer W. in the October *El Farolito*. Further action was tabled until March to include the new service rotation. Debra K. recommended that the area continue to send Archivists to the National Archives Workshops.

It has been an honor and a privilege to serve Area 46 in the capacity of Archives Chair for the last two years. Welcome to Patience B. as the incoming Archives Chair!

Finance

I'd like to take this opportunity to thank Area 46 and Alcoholics Anonymous for my sobriety and allowing me to be of service as your finance committee chairperson. As with any service performed in Alcoholics Anonymous, I have been given many opportunities to grow and experience humility. This kind of service is in line with my higher power's intentions for me and for which I receive the gift of sobriety and the blessing of serenity. I couldn't ask for more.

The December assembly was a busy one as usual for the finance committee. We finalized and presented the 2020 area budget as well as two other important motions for the area to vote on. Based on end of the year projections, the area will end 2019 with a significant amount of available cash which came into play for all three of our motions.

Our 2020 budget has increased from 2019 primarily due to all our

SWRAASA travel expenses as well as a printing of the AIP. Fortunately, we are able to balance this budget by allocating \$2,800 from available cash to our adjusted maximum operating budget. This keeps us in the black and I believe is a good use of the funds.

Through committee suggestions and discussion, we decided to ask the assembly to utilize the remaining 2019 available cash in a couple different ways. First, it was suggested that the convention seed money needed to be increased to cover higher upfront costs. We presented our motion requesting a \$2,000 increase making the seed amount \$7,000. Because we actually have, during about six months of the year, two sets of seed money out, this increase required a \$4,000 allotment. Our second motion came out of our committee discussion regarding our research into nonprofit and tax exempt status. It has become apparent we have to put up some funds to hire a CPA specializing in nonprofits. We proposed spending up to \$1,000. Both of these motions, as well as the 2020 budget, were passed by the assembly.

I'd like to welcome Julio from District 4 as our incoming Finance chairperson. Julio has been a part of our committee these last two years and is definitely up to the task of continuing our work. I look forward to our next rotation of service and the chance to continue trudging the road with Area 46. Thank you for allowing me to be in service.


